

Minutes of DDC meeting held on 05/01/2017 in the conference hall of Deputy Commissioner's Office, Dhemaji.

Members present:- As per Annexure-I

The meeting was presided over by Smti Roshni Apranji Korati, I.A.S, D.C Dhemaji. Wishing all the members a happy new year the meeting was discussed by reviewing the GOI's "Demonitization" policy and accessed the efforts and action of various deptts. in this regard. DC instructed all the deptts. to practice the system of "cashless" or "digital transaction" as far as practicable .

1. APDCL:- The AGM, APDCL informed the house that as per instruction of the D.C in the last DDC meeting , raids have been made in several areas of the Distt. and F.I.R have been lodged against 10 Nos. of electricity thefts. Dist. Dev. Commissioner(DDC) directed him to further intensify such raids and take action. The AGM also appraised the house that the 33 Q.V sub-power station, Bordoloni is being completed. In this connection the Dy. Director, T & CP informed that some electric posts have fallen in the alignment of the newly constructed drain by the highway which needs to be removed. D.C directed the APDCL to take necessary action immediately.

2. AGRICULTURE:- The D.A.O informed the house that high yielding variety (HYV) paddy seeds has been distributed to the beneficiaries in the Distt. A training programme is organized at head quarter on groundnut cultivation. The E.E Agriculture informed that 10 Nos of powertillers under RKVY Scheme could not be distributed to the beneficiaries due to lack of cheque facilities. D.C directed him to submit the beneficiary list alongwith the name of banks sanctioning loan to them.

3. A.H & VETY :- D.C directed the D.V.O to organize awareness/training programme for the SHGs and user groups on poultry rearing at "Hansara" village. D.V.O appraised the house that it could not happen due to lack of medicines and also a vehicle is required to bring the medicines from Guwahati . D.C assured to provide a vehicle for the purpose as and when required. The DDC requested the D.V.O to submit a list of medicines to be supplied immediately.

4. DEEO/I.S :- The concerned officers have informed that 70% of the free textbooks have been received from the Govt. which will be distributed very soon.

5. DSWO:- The D.S.W.O appraised the house that fund under S.N.P has not been received from the Govt. Correspondence is being made to the Govt in this regard. He raised concern that SBI, Dhemaji is delaying payments to beneficiaries despite repeated requests and visits. D.C asked A.D.C Deka to immediately take up with Chief Manager, SBI, Dhemaji and to issue a stern warning.

6. D.F.D.O:- D.C directed the DFDO to identify shallow fisheries/mahals of the Distt. and submit a list thereof to the D.C so that the same could not be excavated through works deptts. if possible.

7. W & R Deptt:- The EE, W & R informed the house that sanction has been accorded for repair & restoration works of dyke at Nilakh Bhebeli of Gainadi. D.C directed him to make spot visit to identify vulnerable embankments of the Distt. and submit a report mentioning the areas and chainage so that those could be taken up under MGNREGA.

8. P.W.D (RR) & (ST.Rds):- D.C directed the concerned deptts. to construct speed breakers on feeder roads to prevent road mishaps. The deplorable condition of Siley & Berachapari was also discussed. In this connection the EE, PWD (RR) informed that an estimate of Rs-1.00 Crore for the said works have been submitted to the Govt. but sanction has not been accorded till date. D.C directed him to submit copies of plan & estimate for taking up the matter with the Govt. Further the E.E PWD State Roads was instructed to repair the approach road to "Habung".

9. P.W.D (N/H):- D.C informed that some portion of the NH road at Samarajan area is very deplorable. The A.E.E, PWD (NH) informed that necessary queries have been met up but the proposal is pending at Ministry of Roads & Transport, Govt. of India.

10. P.W.D (B):- D.C directed the EE, PWD (B) to visit "Habung" which is a place of historical importance of "Ahom Reign" and to prepare a project for tourism and for preserving the cultural heritage.

11. D.F.O (T) :- A.C.F requested all the works Deptts. to submit their requirement for forest materials so as to collect the materials legally. Further he requested that no bill should be submitted without "Forest Royalty Clearance Certificate".

12. H & T:- The beneficiaries selection for distribution of yarn & blankets have been completed and is waiting for distribution.


13. SWATCHA BHARAT MISSION:- D.C laid emphasis on use of toilets by every individuals and ensure of the same by all deptts with regards to the employees of the concerned Deptts.

14. City Project Manager (T.C):- D.C appraised the house that a "Pre Bhugali Mela" is being organized by the women SHGs under Din Dayal Antodaya Yojna & NULM on 10,11 & 12 th January/2017 in the "Nagar Jibika Kendra" situated in the weekly market, Dhemaji. D.C requested all the members to make it a success so as to encourage the SHGs.

15). MISCELLANEOUS:- DC informed the house that DDC meeting will be held on every 5th day of every month in the conference hall of the Deputy Commissioner's office at 11.00 A.M. If the 5th day is a holiday the meeting will be held on the next working day.

The meeting ended with a vote of thanks from the chair.


