

Minutes of DDC meeting held on 07/09/2017 in the conference hall of Deputy Commissioner's Office, Dhemaji.

Members present:- As per Annexure-I.

The meeting was presided over by Smti Roshni Apranji Korati, IAS, Deputy Commissioner Dhemaji. Welcoming all the members present the meeting started by following the minutes of the last DDC meeting read out by Sri D.K Mill, ACS, District Development Commissioner(DDC) Dhemaji.

1. ASEB:- Participating in the discussion , the AGM, APDCL informed the house that 1600 KV transformer will be installed before the forthcoming Durga Puja to enhance the power position of the District. D.C directed him to replace the bamboo posts used as electric posts in the District. In this regard the AGM, APDCL informed that legal notices are issued to the consumers who have been using bamboo electric posts for obtaining electric posts from the ASEB.

2. Agriculture:-The DAO informed the house that he has received 1292 nos. of applications for tractors & powertillers under CMSGUY upto August/2017 from 150 Nos of villages. He also informed that he has distributed black gram seeds to 560 beneficiaries of Gogamukh Rev. Circle. D.C directed him to consult the matter with the concerned circle officer. Further he also informed the house that 580 Hectares of paddy cultivation are affected by the swarming caterpillars of which 295 hectares have been treated and the action taken in respect of the 285 hectares are going on. He further informed that sufficient quantity of pesticides are available with the Deptt. to combat the situation.

3. AH & VETY:- The DVDO informed that the construction works of Sissiborgaon A.H & Vety Centre is completed and the same has been handed over to the user group. He also informed that 166 nos. of cattles including 2 Nos. buffallos, 389 nos. of small animals and 4048 nos. of poultry have died in the recent devastating flood in the District. D.C directed him to include the same in the daily flood report. D.C directed him to give wide publicity in the District for awareness regarding cattle insurance.

4. DEEO:- DEEO informed that some of the school text books have been damaged in the recent devastating flood in the district . She further appraised that she has distributed text books to the flood affected students of the District.

5. DSWO:-Participating in the discussion the D.S.W.O, Dhemaji informed the house that he has distributed biscuits & milk packets to the flood affected people of A.W.Cs .He also appraised the meeting that he has transferred the fund of "Jibanjyoti" scheme to the Govt. as advised by the ADC (Revenue). He informed the house that 90 Nos. of AWCs which were constructed under MGNREGA are not completed. The PD, DRDA informed the house that the estimated cost of one AWC is Rs-7 lakhs and the fund break up is Rs-5 Lakhs to be incurred from MGNREGA and Rs-2 Lakhs to be borne by the Social welfare deptt. He further appraised that 6 Nos of AWCs have been completed and requested the DSWO to release their fund share which has not been made till date.

6. J.D.H.S :-The J.D.H.s, Dhemaji informed the house that he has constituted 4 Nos. of medical teams alongwith essential medicines to visit the flood relief camps of the district which are functioning satisfactorily with no public complaints.

7. Fishery :- The DFDO informed the house that the tender process is going on for construction of 1 Hectare Fish seed farming project at Naharbandana, Jonai.

8. PHED :- D.C directed the EE, PHED to visit Ghuguha relief camp and to provide toilets and to install H.T.W immediately.

9. PWD (B) :- The E.E, PWD (B), Lakhimpur appraised the house that the ongoing construction of ADC's quarter could not be completed in time due to the occurrence of frequent heavy rainfall. He further informed that the Judiciary deptt. quarters are completed. D.C directed him to prepare additional plan & estimate for boundary wall and gate etc for the girl's hostel at Jonai polytechnic, Laimekuri.

10. PWD (St.Rds):- The EE, PWD (St. Rds) Dhemaji appraised that the bridge on Morongi to Kapahtali is restored which was damaged by the recent flood and the const. of Bridge at Gohain Chapari is not completed. D.C directed him to expedite the restoration process.

11. PWD (NH) :- The EE, NH Division informed the house that the plan & estimate regarding construction of the N.H road at Samarajan area is placed before the technical committee for approval. In this regard D.C directed him to intimate the up to date progress of the work. He further informed that the guide bundh at Jalakiasuti at N.H 52 is restored which was damaged by the recent flood.

12. Water Resources Deptt:- The EE, WR Dhemaji informed the house that 14 Nos. of proposals have been recommended under SDRF. Further he informed the house that a sanction of Rs-2(Two) crores have been given for providing of porcupines to protect the Majorbari embankment. D.C requested the Principal Secretary, M.A.C to submit allocation & sanction orders etc. to line deptts. with a copy of intimation to D.C for implementation of MAC works.

D.C directed the concerned Deptts. to prepare vision documents for five years (2017-2022) as sought by the Govt.


13. D.F.O (Territorial) :- D.C directed the DFO (T) to organize a training programme on different bamboo species/ bamboo technology in collaboration with P.D, D.R.D.A, Dhemaji.

D.C requested all the Dist. Heads to set up a flower garden in their office campus and maintain hygiene, cleanliness and beautification.

14. MISCELLANEOUS:- The DDC meeting will be held on every 5th day of every month in the conference hall of the Deputy Commissioner's office at 11.00 A.M. If the 5th day is a holiday the meeting will be held on the next working day.

The meeting ended with a vote of thanks from the chair.
