The meeting was presided over by Smti Roshni Apranji Korati, I.A.S, D.C Dhemaji. Welcoming all the members present D.C complimented the heads of the different Deptts. for extending their active cooperation and participation in the foundation stone laying ceremony of the ICAR, Gogamukh by the hon'ble P.M of India on 26/05/2017 which ended in a great success. D.C further appraised the house that Addl. Chief Secy . to the Hon'ble C.M Assam Sri M.G.V.K Bhanu, will be visiting Dhemaji and will attend Gaon Sabha meeting at Gogamukh GP office on 4<sup>th</sup> June/2017. She directed all the Distt. heads to attend the meeting accordingly.

Thereafter the following discussions took place following the last DDC meeting minutes.

- 1. ASEB:- Participating in the discussion , the AGM, APDCL informed the house that the Hatigarh Sub-Power Station will be completed within two months which is being enhanced from 10K.V to 16K.V Further he informed that FIR has been filed against power thefts in Bordoloni areas and power theft cases have declined. D.C informed that allegations have been received from the public of Ghuguha areas regarding faulty electricity meter reading and instructed the officials to take necessary action in this regard immediately.
- 2. Agriculture:-The DAO appraised the house that SBI, Dhemaji has submitted a list of KCC loan defaulters of the Dist. In this regard the D.C directed the DAO to call for a meeting immediately with the concerned bank officials on recovery of KCC loans and also to set up an agriculture data bank immediately.

The EE, Agri appraised the house that 10 nos. of powertillers have been distributed to beneficiaries under RKVY scheme.

- 3. DEEO:- Participating in the discussion the ADC (Rev) requested the DEEO, Dhemaji to submit plan & estimate of Rs-150000/- each for minor repairing of LPSchools and submit the same to the D.C immediately for onward submission to the Govt. The DC directed the concerned deptts to clean up the present water tanks and submit a photograph thereof on occasion of world environment day on 5<sup>th</sup> June/2017 .In this connection DEEO was also directed to ensure cleaning of school toilets and submit pictorial evidence of the same.
- 4. DTO:- DTO informed that as per direction of the D.C in the last DDC meeting he has seized 8 Nos of China made E-Rickshaws. Further D.C directed him to conduct drives for checking of motor vehicle documents in the Dist.
- 5. <u>J.D.H.S</u>: Expressing concern over the waterborne and other diseases which occurs in the rainy season D.C directed the JDHS to take early measures and to spray mosquito repellant medicines in water logged areas and in the premises of Govt. offices & educational institutions and other vulnerable places so as to protect school students and other masses from Japanese encephalitis etc.
- 6. Fishery: The E.O informed that excavation of 27 nos of individual fisheries have been taken up in the Dist. and 80% progress has been achieved. He also informed that a project is being set up at Mohmara, Jonai for fish farming. The DC directed him to submit plan & estimate in details covering 1 Hect. land for development of fishery in the Dist.
- 7. <u>PWD (B)</u>:- The E.E PWD (B) appraised the house that the const. of Engineering college at Bishnupur, polytechnic at Dekapam, model schools and const. of ADC's Quarter under CM's Spl package are in progress. The ADC's quarter will be completed in 2 months.
- 8.Water Resources Deptt:- Following the direction given by the D.C in the last DDC meeting the EE, WR informed that he has taken preventive measures to protect the "Kasomari embankment of Gainadi river. In this regard Asstt. Commissioner Mustafa A. Borbhuyan appraised the house that he has visited the 4 nos. of FDR Schemes as instructed by the D.C in the last DDC meeting and found some raincuts in the embankments which are needed to be filled up. D.C directed the EE, WR to take necessary steps in this regard. D.C also directed the SDO ( C ) Jonai to allot 1 Bigha land in Simenchapari for construction of A.E.E' Jonai's office building. DC further directed the EE, WR to identify the vulnerable spots of the embankments especially in Gainadi & Jiadhal dyke and take precautionary measures in advance to protect erosion of embankments.

9. SERICULTURE:- The Supdt. of Sericulture , Jonai informed the house that he has submitted plan & estimate of 12 bighas seedbed and 1 Bigha for Som Plantation to SDO( C ) Jonai 10.Vety:- D.C directed the DVO and NRLM to arrange programme for organizing animal health camps and livestock insurance camp in every block/ Vety. Dispensary and submit a report thereof at the earliest.
