1. The beneficiaries shall be selected from the BPL category/ erosion affected families with preference to woman.
2. In case of agricultural item, preference will be given to Field Management Committee (FMC), Agricultural Service Group (ASG) duly registered under Agriculture Deptt. and Self Help Group (SHG) duly registered under P&RD Deptt. from within the areas under the Char Areas Development Project and Development Blocks covering the char areas of the district. Selection of individual beneficiaries will be as per Sl. No.1 above.
3. A group or an individual beneficiary receiving benefit under similar scheme from other Department will not be eligible for consideration.
4. The Char Development Project Officer, Member- Secretary shall call for applications through proper advertisements in news papers & wide publicity and subsequently the applications will be scrutinized by the BDO concerned & the CDP officer. The CDP officer will submit the list of valid applications to the Deputy Commissioner for selection of beneficiaries by the District Level Selection Committee.
5. The Director, Char Areas Development Assam will ensure wide publicity of the scheme through news paper advertisement and other means. Copies of the same will be marked to the Deputy Commissioner of the district, Zilla Parishad Office, Revenue Circle Offices, Blocks and the Char Areas Development Project Offices.
6. The Deputy Commissioner shall review the benefits accrued from the inputs distributed on a monthly basis in the DDC meeting.
7. The CDP officer shall submit monthly progress report and the APRs to the Director, Char Areas Dev. Assam. The Director, Char Areas Dev. Assam will accordingly apprise the Govt.
